Information about Grantmaking

The Commonwealth Fund makes grants in its four major program areas:

- Improving the Quality of Health Care Services
- Improving Insurance Coverage and Access to Care
- Improving New York City Public Spaces and Services
- International Health Care Policy and Practice

Prospective grantees should submit a letter of inquiry via regular or electronic mail. Letters should be brief, no more than 3 pages, and should include:

- contact name
- legal name of grantee organization (please spell out acronyms)
- complete mailing address
- phone number(s)
- e-mail address(es)
- purpose of grant
- description of the project's targeted audience(s)
- estimated total project cost
- total dollar amount requested from the Fund
- project design, including schedule and workplan
- description of the project's expected outcomes
- organization staffing and financial resources

Letters of inquiry are acknowledged when received. Applicants are typically advised of results of an initial staff review within two months. Program staff will contact applicants if more detailed information is required.

Proposals recommended by the Fund's staff are considered and voted upon by the board of directors, which meets three times a year.

The Fund makes grants only to tax-exempt organizations and public agencies.

It does not provide support for:

- general planning and ongoing activities or existing deficits
- endowment or capital costs, including construction, renovation, or equipment
- basic biomedical research
- major media projects or documentaries, unless they are an outgrowth of one of the Fund's programs
- individuals
- scholarships
- churches or other religious organizations, unless the project for which they seek funding is entirely secular in nature
- work for which achievements cannot be measured
