The goal of The Commonwealth Fund's Program on Quality of Care for Underserved Populations is to improve the quality of health care delivered to low-income Americans and members of racial and ethnic minority groups, and to reduce racial and ethnic health disparities. The program builds on efforts to improve quality of care overall in the United States, focusing on safety net institutions and other health care settings that serve large numbers of low-income and minority patients. The strategies it pursues include:

- Finding and promoting models of high performance health systems for the underserved that provide accessible, effective, safe, and efficient health care.
- Promoting health care that is culturally competent and patient-centered.
- Supporting the development of public policy that will lead to improvement in health care systems serving minority and low-income populations.
