Notes: The CARES Act allocates \$3 billion for the United States territories and the District of Columbia. While the legislation does not provide further detail on how funding will be allocated within this pool, for the purposes of this analysis, we estimate the D.C. allocation proportionately based on population. As a result, we project that D.C. will receive an allocation below the minimum of \$1.25 billion that applies to the 50 states. **Bolded states** are projected to receive the minimum CARES Act allocation (\$1.25 billion) regardless of population. *Virginia* expanded in 2019; it is excluded from summary analysis because of a lack of data on expansion expenditures and new uninsured rate.
