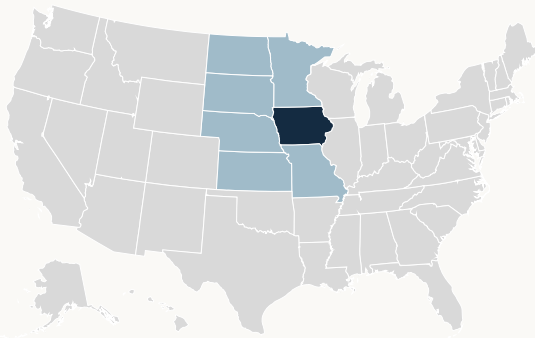

Iowa ranks #18 overall.

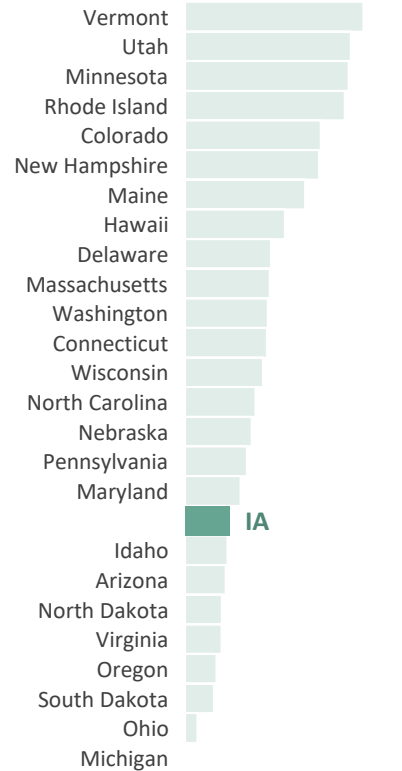

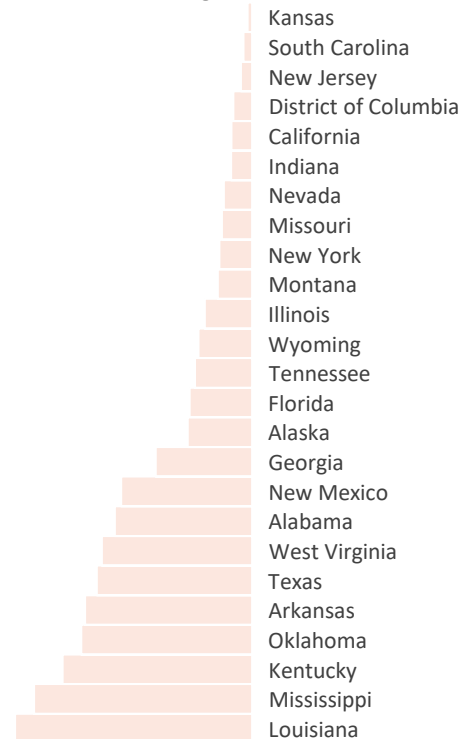
