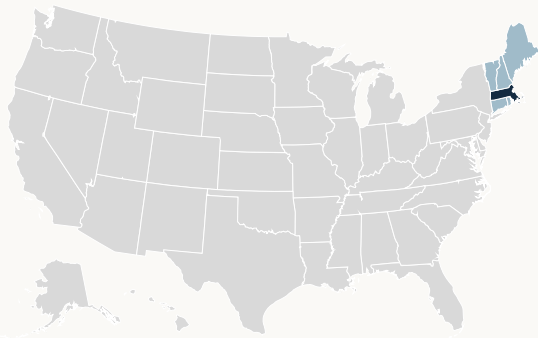

Massachusetts ranks #10 overall.

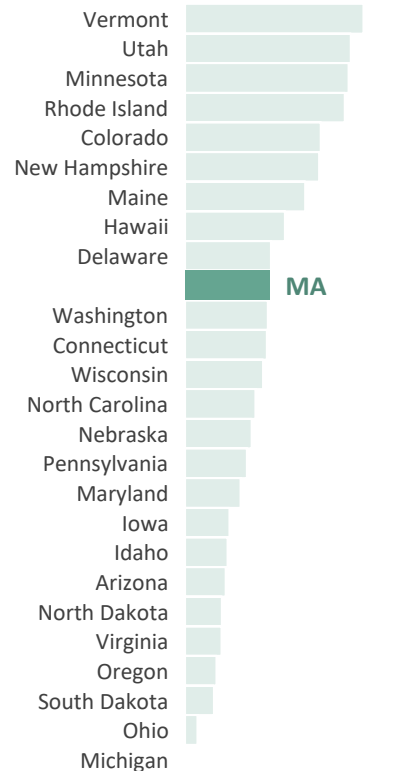

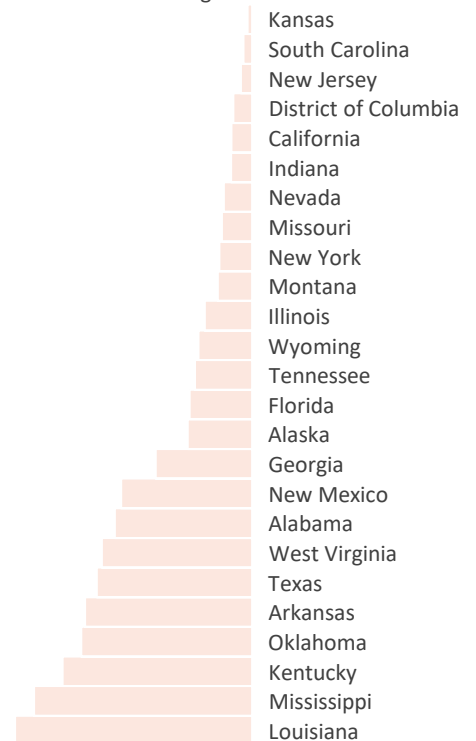
