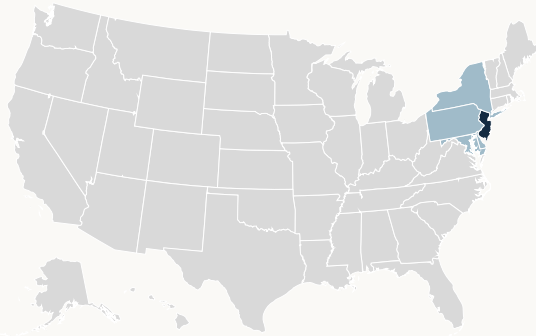

New Jersey ranks #29 overall.

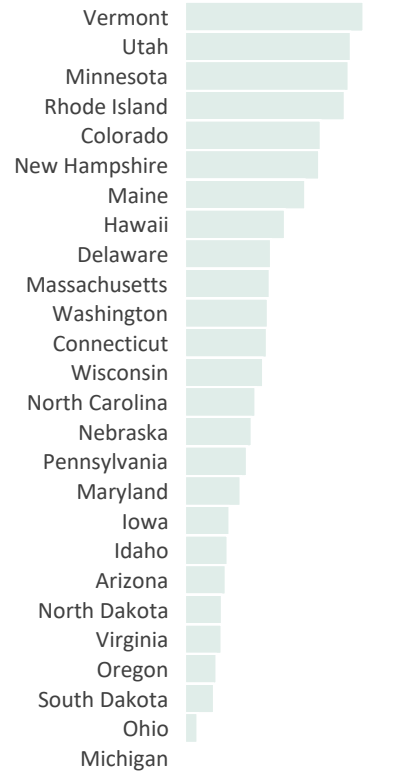
