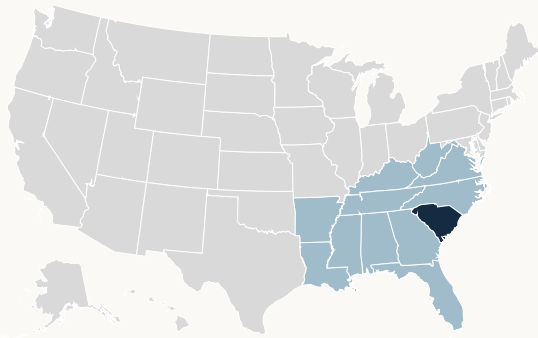

South Carolina ranks #28 overall.

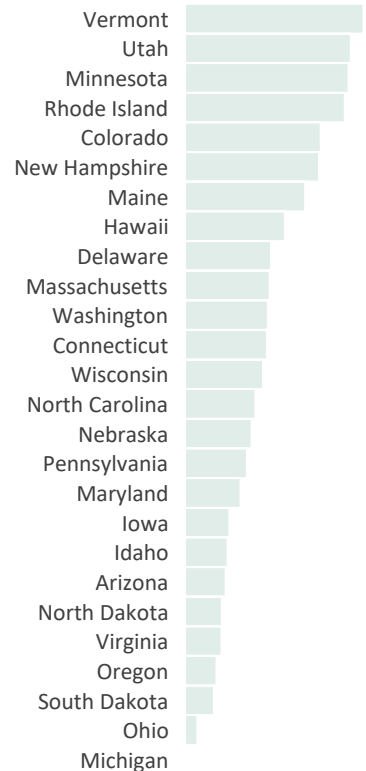

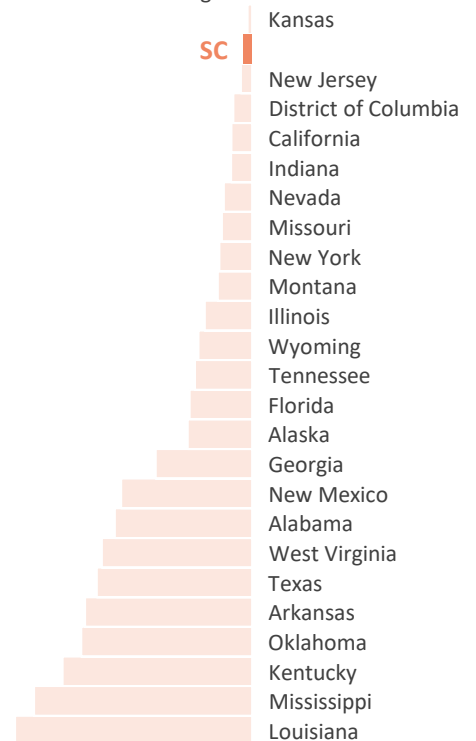
