

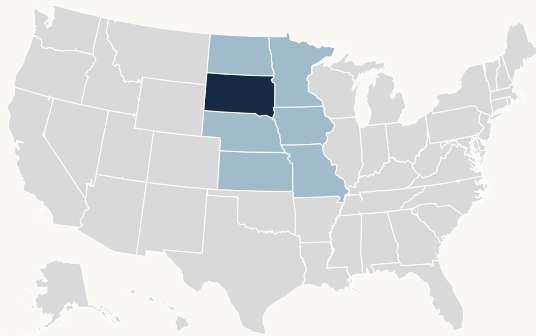

South Dakota ranks #24 overall.

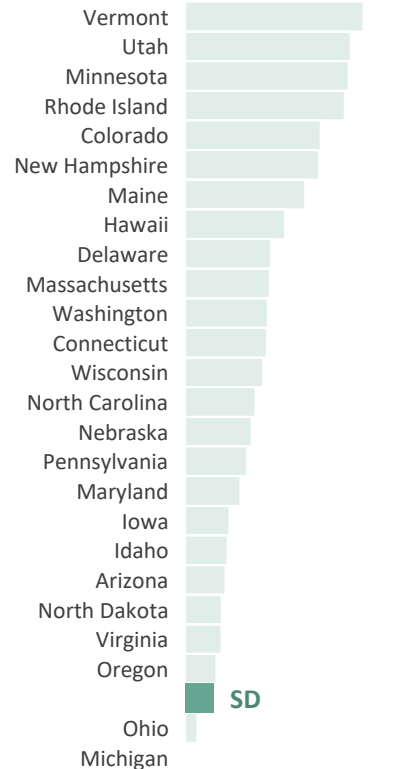
