

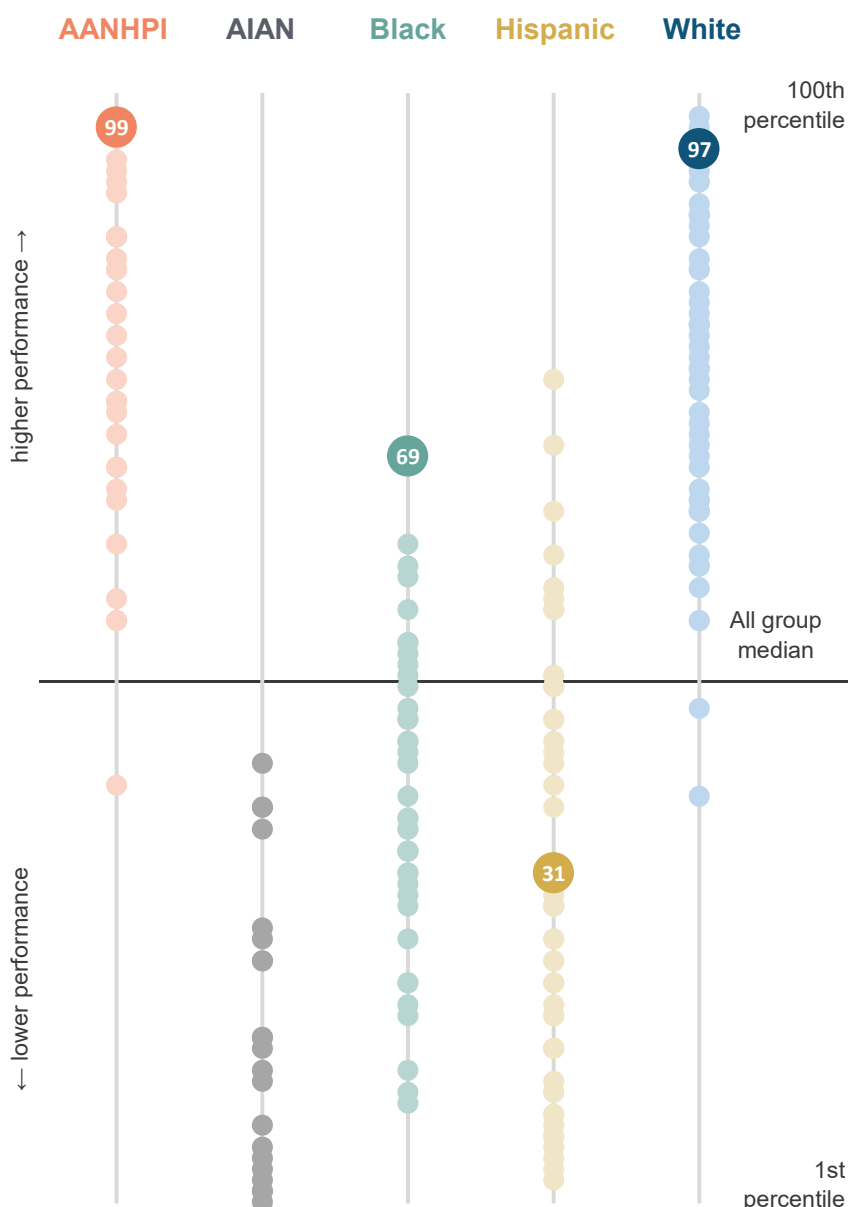
How well does the health care system in Maryland work for people of different racial and ethnic groups?

In Maryland, **AANHPI people** experienced the **best health care outcomes, access, and quality**, scoring in the 99th percentile among all population groups nationally.

Hispanic people experienced the **worst health care outcomes, access, and quality** in the state, scoring in the 31st percentile.

Compared to other states in the Mid-Atlantic region, Maryland has **more severe** racial and ethnic health disparities.

How well does the health system in Maryland work for people from different racial and ethnic groups and across different dimensions of care?

AANHPI

Maryland ranks 1st among the 33 states we were able to rank. This indicates that the state's health system performance for AANHPI people was among the best compared to other states.

Health outcomes ranking: **4** (of 36) is among the best
Health care access ranking: **1** (of 36) is among the best
Health care quality ranking: **3** (of 45) is among the best

AIAN

An overall ranking for AIAN people in Maryland is not available because of insufficient data.

Black

Maryland ranks 1st among the 39 states we were able to rank. This indicates that the state's health system performance for Black people was among the best compared to other states.

Health outcomes ranking: **6** (of 41) is better than the average
Health care access ranking: **1** (of 41) is among the best
Health care quality ranking: **6** (of 45) is better than the average

Hispanic

Maryland ranks 20th among the 49 states we were able to rank. This indicates that health system performance for Hispanic people was better than the average compared to other states.

Health outcomes ranking: **9** (of 50) is better than the average
Health care access ranking: **35** (of 50) is worse than the average
Health care quality ranking: **16** (of 50) is better than the average

White

Maryland ranks 3rd among the 51 states we were able to rank. This indicates that the health system performance for white people was among the best compared to other states.

Health outcomes ranking: **10** (of 51) is better than the average
Health care access ranking: **3** (of 51) is among the best
Health care quality ranking: **4** (of 51) is among the best
