

How well does the health care system in Utah

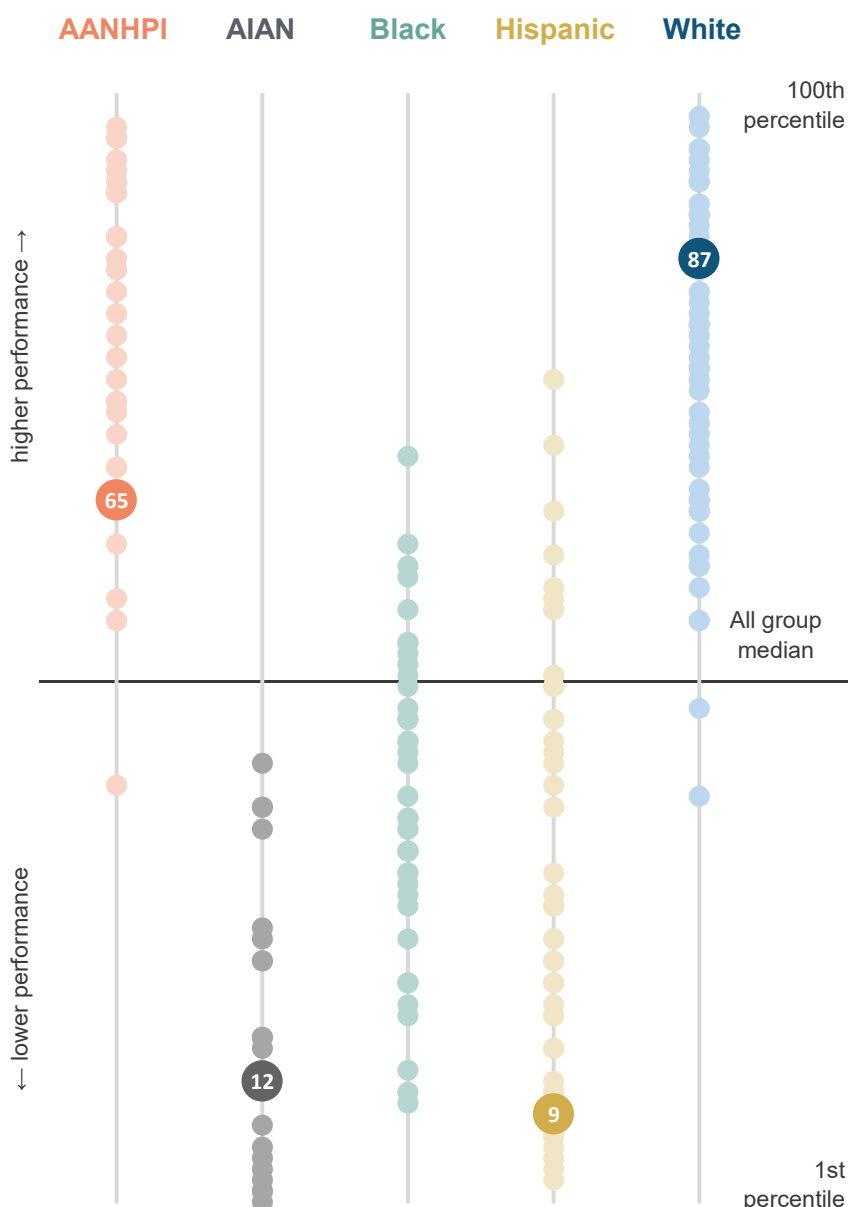
work for people of different racial and ethnic groups?

In Utah, **White people** experienced the **best health care outcomes, access, and quality**, scoring in the 87th percentile among all population groups nationally.

Hispanic people experienced the **worst health care outcomes, access, and quality** in the state, scoring in the 9th percentile.

Compared to other states in the Rocky Mountain region, Utah has **more severe** racial and ethnic health disparities.

How well does the health system in Utah work for people from different racial and ethnic groups and across different dimensions of care?

AANHPI

Utah ranks 28th among the 33 states we were able to rank. This indicates that the state's health system performance for AANHPI people was among the worst compared to other states.

Health outcomes ranking: **35** (of 36) is among the worst
Health care access ranking: **29** (of 36) is worse than the average
Health care quality ranking: **22** (of 45) is better than the average

AIAN

Utah ranks 13th among the 21 states we were able to rank. This indicates that the state's health system performance for AIAN people was worse than the average compared to other states.

Health outcomes ranking: **9** (of 23) is better than the average
Health care access ranking: **13** (of 21) is worse than the average
Health care quality ranking: **18** (of 25) is worse than the average

Black

An overall ranking for Black people in Utah is not available because of insufficient data.

Health outcomes ranking: insufficient data
Health care access ranking: **39** (of 41) is among the worst
Health care quality ranking: **1** (of 45) is among the best

Hispanic

Utah ranks 41st among the 49 states we were able to rank. This indicates that health system performance for Hispanic people was worse than the average compared to other states.

Health outcomes ranking: **15** (of 50) is better than the average
Health care access ranking: **42** (of 50) is worse than the average
Health care quality ranking: **38** (of 50) is worse than the average

White

Utah ranks 15th among the 51 states we were able to rank. This indicates that the health system performance for white people was better than the average compared to other states.

Health outcomes ranking: **4** (of 51) is among the best
Health care access ranking: **31** (of 51) is worse than the average
Health care quality ranking: **12** (of 51) is better than the average
