The mission of The Commonwealth Fund is to promote a high performing health care system. The Fund carries out this mandate by supporting independent research on health care issues and making grants to improve health care practice and policy. International Program in Health Policy and Practice

The Fund's international program examines innovative models for improving care from around the world and fosters cross-national research and collaboration.

Annual International Symposia

Since 1998, the Fund has hosted an annual international symposium in health care policy on a topic of concern to the United States and other industrialized nations. The symposium brings together leading policy thinkers to consider current health care policy issues. Participants include health ministers or their designates from Australia, Canada, New Zealand, the United Kingdom, the United States, Germany, and the Netherlands, as well as experts from each country and leading U.S. policymakers and researchers.

Annual International Health Policy Surveys

Each year, the results of the Fund's International Health Policy Survey are presented at the International Symposium. The surveys have elicited the views of whole populations and sub-populations (e.g., sicker adults, the elderly, hospital chief executives, primary care physicians) in Australia, Canada, New Zealand, the United Kingdom, the United States, Germany, and, in 2006, the Netherlands on such issues as views of the health care system, access to care, quality and safety of care, and costs.
